

*We propose the council support our local community & match the generous donation of £25k provided by the Kitchings charity towards the refurbishment of the local children's play park.*

*As highlighted by the public at our electors meeting, we achieved very little in 2024/2025 and have significant funds available. There was clear dissatisfaction with the councils work & this is an opportunity to have a really positive impact on our local community.*

*These funds should be provided to the play park working committee for them to decide how to best spend the funds as they understand what is needed, priorities etc.*
